



Memorandum of Understanding

1. In this MoU, words and expression shall have the same meanings as are respectively assigned to them in the documents deemed to form and be read and construed as part of this MoU; 2. In consideration of the payments to be made by the Client to the Service Provider as per the MoU, the Service Provider hereby covenants with the Client to execute and complete the Services in accordance with the provisions of the MoU;
3. The Client hereby covenants to pay the Service Provider in consideration of the successful execution and completion of the Services wherein the Fee becomes payable under the provisions of



MoU at the times and in the manner prescribed by the MoU.

4. The following documents shall be deemed to form and be read and construed as part of this MOU, viz.

(i) This MoU between the Client and the Service Provider;

(ii) The proposal submitted by the Service Provider read in accordance with this MoU. Any discrepancy between the terms and conditions indicated in this MoU and Service Provider's Proposal, the terms indicated in this MoU shall prevail.

5. Applicable Law: This MoU shall be interpreted and construed only in accordance with Laws of Republic of India.

6. Jurisdiction: The courts within Coimbatore, Tamil Nadu, India alone will have jurisdiction in respect of the matters arising in connection with and/or under this MoU.

7. No amendment to this MoU shall be valid or be of any effect unless the same is agreed to in writing by both the Parties hereto and specifically stated to be an amendment to this MoU.
